## Rental Contract Terms and Conditions

1. At the end of the introductory period, this instrument may be returned and this agreement cancelled.
2. At the end of the introductory period, the customer has the option to extend the rental on a monthly basis. All rental payments are due in advance. There are no refunds on rental fees.
3. The price for each one-month extension period is: Violins and Violas are \$15.48 plus sales tax and \$2.50 insurance; Cellos are \$29.60 plus sales tax and \$3.50 insurance; Upright Bass is \$55.00 plus tax and \$8.00 insurance.
4. The customer is always offered the option to purchase their instrument in full. 100% of all rental payments will be applied toward the purchase during the first thirteen (13) months of rental. 75% of all rental payments will be applied to the purchase after the first thirteen (13) months. Rental payments are applied only to the purchase of an instrument and not cases or accessories. A 30% discount is available off of the unpaid balance when instrument is purchased. Anytime!
5. The instrument may be returned at anytime and this contract cancelled provided that all payments are paid to date.
6. Instruments may be exchanged for a larger size at no additional cost while renting.
7. Title and ownership of the rental instrument remains with Gerry's Music Shop Inc. until customer makes all rental and other payments required under this agreement or exercise their purchase option. If the customer declares bankruptcy, we retain title, and the instrument must be returned to us immediately.
8. By signing this Rental Agreement, the customer agrees to all terms and conditions. The customer acknowledges receipt of the musical instrument listed above. The customer assumes all responsibility for the instrument during the period of the contract not outlined by our Comprehensive Maintenance Insurance Plan.
9. A late fee of \$5.00 will be assessed to payment if account becomes 15 days past due. After 30 days, failure to pay will result in default.
10. Gerry's Music Shop Inc. will recover all expenses, including legal fees, which result in any legal action taken to recover possession of the instrument.
